

PUBLIC NOTICE OF FY-2017 ALDOT PROGRAM OF PROJECTS

Public Notice of Program of Projects

The Alabama Department of Transportation is submitting grant applications to the Federal Transit Administration, a division of the U.S. department of Transportation, for funding in support of transit programs indicated below. The grant applications seek funding to support operational, administrative, planning, and capital project activities.

These grants will fund statewide projects for Small Urban Transportation, Rural Transportation, Bus & Bus Facilities, and Enhanced Mobility of Seniors & Individuals with Disabilities Transportation. A brief description of each project and the available funding amounts follow:

Section 5307 and 5340 Small Urban Grant

This grant will provide federal funds for capital and operating. Available federal funding is \$5,523,976 for the support of projects that meet the transportation needs in the small urbanized areas of the State. Funding will be provided for the following urban areas: Anniston (\$903,857), Auburn (\$982,684), Decatur (\$834,618), Dothan (\$1,207,691), Florence (\$939,926), Daphne-Fairhope (271,179), and Phenix City (\$384,021).

Section 5311/5340 Rural Grant, 5311(b)(3) RTAP, 5311 (c)(2) Appalachian Development, and 5311(f) Intercity Bus

This grant will provide federal funds for operating, administrative, planning, and capital. Available federal funding is \$20,641,376 for the support of projects that meet the public transportation needs in the rural areas of the State, intercity needs, Appalachian area needs, Job Access Reverse Commute needs, and for the Rural Transit Assistance Program (RTAP) which provides assistance with training and technical assistance to meet the needs of the transit providers.

Section 5339 Bus and Bus Facilities Grant

This grant will provide federal funds for capital. Available federal funding is \$791,364 for the support of projects that meet the transportation needs in the small urban areas of the state.

Section 5310 Enhanced Mobility of Seniors & Individuals with Disabilities Grant

This grant will provide federal funds for administrative, capital and New Freedom transportation initiatives. Available federal funding for small urban and rural areas of the State is \$2,187,070. Funding will support projects that meet the transportation needs of seniors and individuals with disabilities plus New Freedom initiatives.
